

**COVID-19 POLICIES AND SAFETY
MEASURES**

We are so thrilled that we will once again be able to host the Grand Canyon State Feis and the Scottsdale Feis. We take the safety of all those attending very seriously. As such, there will be strict safety policies in place that must be adhered to. We look forward to running a safe and fun feiseanna weekend!

Failure to comply is grounds for ejection from the event.

REGISTRATION

1

- Before registering, please check all applicable travel advisory rules. There will be absolutely no refunds for any reason, including but not limited to: changes in quarantine requirements, illness, or any other COVID-19 related issues. If our feis committee has to cancel for any reason, registration refunds will be issued to all competitors minus a \$5 administration fee per payment.

2

- Championship dancer order will be assigned at random before the feis and posted on Feisworx. Please carefully make the proper dance and music selections during registration to ensure your dancer is placed in the correct group. The order will be posted after registration closes prior to the feis.

3

- There will be no day of feis changes, additions, or entries due to the Covid-19 pandemic. (Exception is level advancement on Saturday. See the Grand Canyon State Feis syllabus for instructions).

4

- Spectators will need to register before the feis and fill out a Health Questionnaire and Liability Release. Keep an eye on Feisworx for this document.

5

- Print your dancer number card at home. Instructions are available with your Feisworx registration.

AT THE FEISEANNA

1

- Temperatures will be taken prior to admittance to the feiseanna. Those with elevated temperature at/above 100.3 will not be allowed into the event.

2

- Spectators will need to pick up their wrist bands at check in. Bands will be under the dancers' names. Wristbands cannot be given unless the Health Questionnaire and Liability Release form has been filled out (will be available on Feisworx).

3

- Spectators will be limited to TWO per dancer. Please stay in your chairs and do not accompany dancers to the stage or move to watch dancing.

4

- We will be adhering to the CDC's recommendations regarding masks. As such, masks must be correctly worn AT ALL TIMES. Masks should cover the nose and mouth. If you are unable or unwilling to adhere to this policy, we ask that you do not attend this year.

5

- Please observe social distancing protocols at all times, including at the vending booths. Adhere to related requests made by the vendors.

Dancers

1

- Dancers are not required to compete in their masks. Please bring a small bag to place it in while competing. Masks will be placed in a designated area side stage. Dancers should immediately retrieve and put their masks back on as soon as their round is completed. Masks and the bags may not have any identifying markings (ie: no school symbols or lettering, etc.)

- There will be NO practice floor or warm up area. Please arrive warmed up and ready to dance.

3

- Please arrive no more than 15 minutes prior to when your competition is scheduled to begin. Keep an eye on our social media for schedule adjustments.

4

- Dress for awards list will be announced on social media.

5

- Only Championship awards will be announced and given in-person. Results for Grades will be posted on Feisworx only. There will be a designated area to pick up awards. Awards will not be mailed.
